SAARC CCI Membership Categories

Corporate Members:	This membership is open to corporate entities having a minimum turnover of Fifty (50) Million USD per annum in case of developed countries and Five (5) Million USD in case of less developed countries The application should have physical presence in any one of the SAARC countries, members will have the right to attend both EC and GA meetings as a observers.
Patron Member:	This Category of Membership is Open to those Individuals or Corporate entities who have excelled or specialised in any specific field likely to benefit the region as whole or improve the life of individuals in any SAARC Country.
Life Member:	This type of membership is open to business person (both male and female) and over twenty five years of age with membership criteria as following: <ul style="list-style-type: none">• He shall be a genuine businessman/woman.• He shall have a bank account on his company name.• He shall produce a Certificate of proprietorship/ partnership/ Company Registration, from competent authorities of respective country.• Valid Certificate of membership/ Affiliation with any chamber/ association from his respective country.

Criteria to Seek SAARC CCI Membership

1. Whereas the Committee shall follow Membership criteria as hereunder

- 1.1 Be one of the leading tax payers of his/her respective country and proof of the tax returns
- 1.2 Members of any Trade/Industry related Association/ Chamber
- 1.3 Having minimum annual turnover equivalent to
 - For life Members (US\$ 1.0 million for male and US\$ 0.5 million for female)
 - For Patron Members (US\$ 2.0 million for male and US\$ 1.0 million for female)
- 1.4 Certificate of proprietorship/partnership or company registration from competent authority of respective country

10. Certificate of proprietorship/partnership or company registration from competent authority of respective country.
11. Copy of valid Membership certificate of any Chamber or Association from his/her respective country.
12. Demand Draft/Pay order in favour of SAARC Chamber of Commerce & Industry
