"But, due to the recent violent activities of political parties, the country's business, trade, and investment

are at risk. At the same time, there is a deliberate attempt to create chaos in the ready-made garment sector," he added.

Stating that the country's political unrest is pushing the national economy to uncertainty, the FBCCI president said the prevailing situation is severely disrupting the country's supply chain and thus affecting production, market prices, and export and services sectors as well.

FBCCI President Mahbubul Alam is leading the delegation of 44 businessmen representing various sectors of the country.

The visit is expected to play an important role in strengthening trade and investment ties among Commonwealth countries. The delegation's itinerary includes participation in a series of programs and events during their stay in the UK.

The FBCCI delegation will attend a welcome dinner hosted by the Bangladesh High Commission on November 26, 2023. FBCCI President Mahbubul Alam is scheduled to attend the inaugural session of the Commonwealth Trade and Investment Summit on the morning of November 27th. On the same day, Mahbubul Alam will also attend a dinner hosted by the chairman of the City of London Chamber.

On the second day of the Commonwealth Trade and Investment Summit (November 28, 2023), FBCCI President Mahbubul Alam will participate as a panelist in a round table session focusing on 'Tech and Innovation: Enabling Trade.' FBCCI will also engage with and sign a Memorandum of Understanding (MoU) with the UK Bangladesh Catalysts of



Commerce and Industry (UKBCCI).

FBCCI and Bangladesh High Commission Join Hands to Boost Exports in UK



The Federation of Bangladesh Chambers of Commerce and Industry (FBCCI) and the Bangladesh High Commission in the United Kingdom (UK) have reaffirmed their commitment to collaborate in tapping into the expanding of exports in the UK market. During a dialogue held on November 26, 2023, FBCCI President Mahbubul Alam led a business delegation in

discussions with Ms. Saida Muna Tasneem, the Bangladesh High Commissioner in the UK.

The key focus of the talks was the diversification of export goods to capitalize on the UK consumer market, export of skilled manpower. President Mahbubul Alam stressed the importance of reducing dependence on the ready-made garment sector and exploring opportunities in agricultural products, leather goods, jute products, flowers, and fruits.

"We are working on identifying products beyond the garment industry that can be exported to the UK," said Mahbubul Alam, urging entrepreneurs to contribute to this diversification initiative.

Highlighting the current economic challenges and the imperative of diversification, he added, "Considering the current economic context, LDC graduation challenges, it is important to diversify the export items."

FBCCI President said, The Honorable Prime Minister is working tirelessly to advance the business sector of the country. He called for increased cooperation from the Bangladeshi High Commission in attracting foreign investors and enhancing Bangladesh's export income. The President also urged commercial counselors in various countries to play a more active role in supporting businessmen.

Bangladeshi High Commissioner in the UK Saida Muna Tasneem said, Bangladesh exported goods worth more than 5.5 billion dollars to the UK last year with the joint initiative of the Bangladesh High Commission and the private sector. Which is the highest in terms of export of Bangladeshi products to the UK in a fiscal year. 91 percent of these exports come from ready-made garments, she added. Various types of products including textiles, fisheries, bicycles are also exported to the UK, but the number is very less.

To bolster exports further, the High Commissioner highlighted the importance of utilizing the China Plus One policy and

explored opportunities in exporting diverse products, including fruits like pineapples and various agricultural goods.

Discussing the mainstream market in the UK, High Commissioner Saida Muna Tasneem said, "If we can analyze the demand for products in the UK market and their origin, it will help us increase our country's exports."

The meeting also addressed the potential export of skilled manpower, including trained nurses. Business leaders and officials from the Bangladesh High Commission in the UK were present at the program.

Mahbubul Alam, President of the Federation of Bangladesh Chambers of Commerce and Industry (FBCCI), has emphasized the importance of knowledge, technology, and skills sharing among Commonwealth nations to effectively address the challenges posed by the Fourth Industrial Revolution (4IR). He made these comments during a roundtable discussion on 'Tech and Innovation: Enabling Trade' held on November 28, 2023 at the Glaziers Hall in London, UK, on the second day of the Commonwealth trade and investment summit. FBCCI President attended the discussion as a panelist.

Mahbubul Alam highlighted Bangladesh's vision to transform into a Smart Country by 2041 under the leadership of the Honorable Prime Minister Sheikh Hasina. The successful realization of the Digital Bangladesh goal has laid the foundation, with the integration of technology and artificial intelligence being the linchpin for future progress, he added.

Emphasizing the need for ethical and responsible technology use, President Mahbubul Alam outlined steps Commonwealth countries can take, including encouraging innovation through investment,

protecting innovators' rights, and enacting comprehensive regulatory frameworks.

Discussing the rapid advancements in Artificial Intelligence (AI), FBCCI President called for Commonwealth collaboration to ensure knowledge transfer and the equitable use of Generative AI, suggesting the establishment of a common digital trade information platform to foster collaboration among the member countries.

Among others, the Vice President of FBCCI Shomi Kaiser, FBCCI Directors, and Business leaders from the Commonwealth countries were present at the program.

FBCCI and UKBCCI Signs MoU

Mr. Mahbubul Alam, The President of The Federation of Bangladesh Chambers of Commerce and Industry (FBCCI) President has urged expatriates living in various countries, including the United Kingdom (UK), to invest in Bangladesh to strengthen the country's economy and build modern and prosperous country by 2041.

He made this call during an agreement signing ceremony between FBCCI and UK Bangladesh Catalysts of Commerce and Industry (UKBCCI), an organisation of expatriate businessmen of the UK, at the Regent Lake Banquet Hall in London on November 29, 2023. FBCCI President Mr. Mahbubul Alam and UKBCCI President Mr. MG Golam Miah signed on the MoU on behalf of their organizations.

According to the agreement, FBCCI and UKBCCI will work to strengthen bilateral trade between the UK and Bangladesh, identify potential sectors and increase investment in Bangladesh.

While speaking at the meeting, FBCCI President Mr. Mahbubul Alam said, "the United Kingdom and Bangladesh have a long-shared history. Today our bilateral ties are



multi-faceted with growing trade and investment. We are presented with the opportunity to negotiate a new bilateral trade

agreement. This agreement must aim to benefit both our economies, ensuring continued market access for Bangladeshi products and fostering British investments in our growing market. This is taking into consideration Bangladesh's post LDC status."

Mentioning that the government has been working for a long time to ensure an investment-friendly environment in the country, Mr. Mahbubul Alam said that not only foreign investors, but also expatriate Bangladeshis scattered in different countries of the world, including the UK, can benefit by investing in the country.

The FBCCI president told the expatriate businessmen

that the Prime Minister has given various facilities including 10-year tax holiday for foreign investors. An investor can bring together his income or dividends at any time. "I think, except Bangladesh, no other country in the world has such facilities. So, come and invest in Bangladesh. This will benefit you as an investor and the country. Common people will get employment, the country's economy will be stronger, the country will move forward," the FBCCI chief said.

He also mentioned that the FBCCI will provide all kinds of support to expatriate businessmen, if they invest in Bangladesh.
