


Secretary General of FBCCI briefed Administrator about the activities of FBCCI, its opportunities and challenges.

Bangladesh- Brazil Trade Opportunities and Challenges

Bangladesh is the world's 2nd largest apparel exporter after China. Bangladesh is also the largest producer of raw jute (the best environment-friendly fiber), 3rd largest rice producer, 3rd largest vegetable and freshwater fish producer. Our economic growth is fueled by major development in infrastructure and the best uses of our resources. Brazil being the most influential country of South America, a rising economic power of BRIC countries, could be a new frontier for trade and investment from Bangladesh. Brazil is a big country and their purchasing power is also big. But this South American market remained unexplored until recently.

There is immense potential of business, trade promotion, and investment opportunities between Bangladesh and Brazil, which has surpassed 2 billion dollars in the past two years. In fact, bilateral trade between the countries reached \$2.7 billion last fiscal from \$1.5 billion in 2021. Bangladesh mainly imports soya, soybean oil, cotton and sugar, worth over \$2 billion. The export of ready-made garments is about \$200 million. Bangladesh does not get any duty-free market access. Bangladesh looks forward to getting for duty-free market access of ready-made clothes to Brazil.

But to increase it more, Bangladesh needs to sign the PTA with MERCOSUR. MERCO-SUR-Bangladesh Preferential Trade Agreement (PTA), if concluded will enhance the business opportunities and foster private sector engagements between Bangladesh, Brazil, and the other MERCOSUR State Parties, significantly contributing to the promotion of South-South Cooperation. For this Bangladesh is keen to commence of the process for negotiating MER-COSUR Bangladesh Preferential Trade Agreement (PTA), at the earliest opportunity.

Brazil is a member of the BRICS. Bangladesh wants to join the group. Brazil is also the current president of the G-20. So, Brazil can help Bangladesh to join the group. If not as a member, Bangladesh likes to participate in three sectors of G20 under Brazil's Presidency-

- i) environment and climate sustainability working group;
- ii) empowerment of women working group and
- iii) the task force for the launching of the global alliance against poverty and hunger.

It is to be noted that in 2023, President Lula and Bangladesh counterpart met on the sidelines of the BRICS Summit in South Africa and agreed to have increasing cooperation and exchanges in the fields of agriculture, livestock, science, technology and innovation, education, climate change and energy transition, and technical cooperation, among others.

Brazil is a major exporter of edible oil, sugar, cotton, ethanol, semi- finished iron, and other products to Bangladesh. While Bangladesh is a major supplier of ready-made garments to Brazil. Bangladesh also provides jute products like jute bag and jute sack for Brazilian Coffee industry. Bangladesh trade with Brazil has increased from \$1.5 billion in 3 years to \$2.7 billion within a short span of time.

Bangladesh and Brazil have huge potential for bilateral trade in a number of sectors, if both countries resolve trade barriers, especially Brazils imposing 30%-35% tax on Bangladeshi products. Bangladesh's 40 million out of 175 million people, have adequate purchasing power and Bangladesh can be a good destination for Brazil exports. So both parties work together to unleash the opportunity by overcoming the challenges.



Key Industries for Collaboration:

Key Industries for Collaboration between Bangladesh and Brazil:

1. Agriculture: Both Bangladesh and Brazil have significant agricultural sectors, albeit with different focuses. Brazil is a global powerhouse in agribusiness, known for its large-scale production of soybeans, sugarcane, coffee, and beef. Bangladesh, on the other hand, is renowned for rice production and fisheries. Collaboration in agriculture could involve knowledge exchange, technology transfer, and joint research initiatives to improve productivity, enhance food security, and explore new markets.

2. Textiles and Garments: Bangladesh is one of the world's largest exporters of textiles and garments, while Brazil has a burgeoning textile industry. Collaboration in this sector could involve vertical integration, where Brazilian textile manufacturers provide raw materials to Bangladeshi garment factories, taking advantage of Bangladesh's expertise in garment manufacturing and Brazil's cotton production capabilities. Joint ventures could also explore sustainable practices and innovative technologies improve efficiency and reduce environmental impact.

3. Technology: Both Bangladesh and Brazil have made strides in the technology sector, with growing IT industries and a burgeoning startup ecosystem. Collaboration in technology could involve partnerships between Brazilian and Bangladeshi tech companies to develop innovative solutions for common challenges in areas such as e- commerce, fintech, healthcare, and education. Joint ventures could also facilitate technology transfer and skill development through exchange programs and collaborative research projects.

4. Renewable Energy: Brazil is a global leader in renewable energy, particularly in hydropower and biofuels, while Bangladesh has been investing in renewable energy sources such as solar and wind power to meet its growing energy demands sustainably. Collaboration in renewable energy could involve sharing best practices, technology transfer, and joint investment in renewable energy projects. Partnerships could focus on developing solar and wind farms, promoting energy efficiency, and implementing smart grid solutions to enhance energy security and mitigate climate change.

5. Infrastructure Development: Both Bangladesh and Brazil face infrastructure challenges, including transportation, logistics, and urban development. Collaboration in infrastructure development could involve joint ventures or public-private partnerships to finance and execute large-scale infrastructure projects such as roads, bridges, ports, and urban infrastructure. Brazilian expertise in construction and engineering combined with Bangladeshi market knowledge and investment opportunities could create significant synergies and opportunities for collaboration.

In summary, collaboration between Bangladesh and Brazil in key industries such as agriculture, textiles, technology, renewable energy, and infrastructure development holds immense potential for mutual benefit. By leveraging each other's strengths, resources, and expertise, both countries can drive innovation, create jobs, and foster sustainable economic growth. Joint ventures, partnerships, and knowledge exchange initiatives are essential for unlocking the full potential of this dynamic collaboration and shaping a brighter future for both nations.
