In addition to that, we stressed on enhancing capacity of local industries, especially CSMEs, for a sustainable graduation during the meeting with United Nations Committee on Development Policy (UNCDP).

Our engagements with international organizations, including the Asian Development Bank (ADB) and German International Cooperation (GIZ) have focused on evaluating governance and microfiscal pillars for Bangladesh ensuring climate protection and public safety in all construction initiatives. FBCCI also took into cognizance the possible impact of Bangladesh's joining Design Law Treaty (DLT), an international framework for protection of industrial designs by having a meeting with relevant business people.

Despite continuous challenges faced by the private sector, FBCCI remains committed to fostering a business-friendly environment. As a part of regular portfolio discussions with sectoral associations to help understand their needs better and gather insights for upcoming reforms, especially ahead of FBCCI election.

Finally, I want to express my sincere gratitude to all our members, business leaders, and stakeholders for their continued support. Together, we can continue driving economic growth for a more prosperous future for Bangladesh.

## **FBCCI held a meeting with UNCDP**

CSMEs are at the Heart of Economic Development, Employment Generation and Sustainable Graduation of Bangladesh



FBCCI organized a discussion meeting with Mr. Taffere Tesfachew, Member of the United Nations Committee on Development Policy (UNCDP) and Rapporteur for Bangladesh on graduation issue, on November 26, 2024 at the FBCCI office in Gulshan, Dhaka. Mr. Md. Hafizur Rahman, Administrator, FBCCI chaired the meeting.

While delivering the welcome address, FBCCI Administrator Md. Hafizur Rahman said that Bangladesh successfully met three criteria like Income Per Capita, Human Assets Index and Economic & Environmental Vulnerability Index, for a sustainable graduation. This achievement has brightened Bangladesh's image in the international arena, helped generate ample opportunities to increase FDI (Foreign Direct Investment) and increased the confidence of the private sector to expand the business.

The meeting stressed on boosting the capacity of Cottage, Small and Medium Industries (CSME) to ensure sustainable graduation. Administrator, FBCCI put special emphasis on export diversification, exploring new markets, research and innovation in the private sector, boosting productivity through skills development and utilization of technologies. He also sought continued support from the UN in this regard.

Member of UNCDP Mr. Taffere Tesfachew said that Bangladesh could be a role model for other LDCs, provided that public-private collaboration is ensured and integrated efforts are undertaken for transitioning to smooth graduation.

tax to GDP ratio, and implementing the National Single Window (NSW) as the earliest possible time. FBCCI also emphasized on the necessity of separating NBR's Tax/VAT Administration from the Policy Wing, as this will pave the way for removing clashing interest between Tax Wing & Policy Wing of NBR.
