Throughout January, FBCCI organized a good number of significant meetings with its international counterparts, including the Bangladesh-Turkey Business Roundtable, attended by Hon'ble Commerce Adviser of Bangladesh and Hon'ble Trade Minister and Deputy Trade Minister of Turkey; a discussion meeting with UKBCCI accompanied by Ms. Rupa Huq, Member of Parliament of the United Kingdom; with a visiting high level delegation from FPCCI Bangladesh-Pakistan Business Fourm hosted by FBCCI; and a discussion meeting with a delegation from the Board of Investment of Nepal. These meetings aimed to bolster bilateral trade, encourage Foreign Direct Investment (FDI), and explore avenues for mutual economic and investment collaboration. FBCCI also signed an MoU to establish the Joint Business Council with the Pakistan Chambers of Commerce and Industry (FPCCI).

In addition, FBCCI engaged in fruitful discussions with business leaders from various chambers, associations, and forums, including the Bangladesh Auto Biscuit and Bread Manufacturers Association, Bangladesh Sustainable and Renewable Energy Association, Australia Bangladesh Business Forum, and the International Business Forum of Bangladesh, to listen to sectoral concerns and explore opportunities for collaboration.

As the apex trade organization, FBCCI has consistently represented the diverse business community in significant dialogues. Additionally, FBCCI continued its proactive engagement with government agencies, local counterparts, and international partners throughout the month.

Finally, I would like to express my sincere gratitude to all our members, business leaders, and stakeholders for their continued support. I strongly believe that together we can build a prosperous Bangladesh.

FBCCI Organized a Seminar on Power & Energy

FBCCI, the country's apex trade body, organized a seminar titled "Power and Energy Scenario in Bangladesh: Ensuring Energy Security for Development" on January 25, 2025, at the FBCCI office in Motijheel, Dhaka.

Hon'ble Adviser to the Ministry of Power, Energy and Mineral Resources Muhammad Fouzul Kabir Khan graced the seminar as the chief guest.

FBCCI Administrator Md. Hafizur Rahman chaired the seminar.

The seminar stressed on ensuring energy security in Banglathrough exploring desh off-shore and on-shore sources of gas and coals, reducing the system losses in the Power & Energy sector, adopting cost-effective energy strategies, reducing import dependdiversifying ence, energy sources, and increasing the use of renewable energy, etc.

In his address, the Power, Energy, and Mineral Resources Adviser highlighted that the ministry has been giving special importance in promoting good governance and practices of competition in the power and energy sector in Bangladesh. He sought the cooperation of all stakeholders, including businessmen, to achieve this goal.

FBCCI Administrator Md. Hafizur Rahman said that to enhance trade and investment in the country, uninterrupted and high-quality energy is essential. He urged the government to take necessary measures to explore domestic resources.

During the seminar, Energy Adviser of the Consumers Association of Bangladesh (CAB) Dr. M. Shamsul Alam emphasized on enhancing the capacity of Bangladesh Energy Regulatory Commission (BERC), and bringing necessary reforms as well.

Meeting between FBCCI and UKBCCI FBCCI Encourages British-Bangladeshis to invest in Bangladesh



The Federation of Bangladesh Chambers of Commerce and Industry (FBCCI) has urged the British-Bangladeshi entrepreneurs to invest in the country's infrastructure sectors including energy, technology, education and human resource development, blue-economy and tourism.

The call was made at a view-exchange meeting between FBCCI and UK Bangladesh Catalysts of Commerce and Industry (UKBC-CI) held on January 6, 2025 at Hotel Pan Pacific Sonargaon in Dhaka.

The meeting was presided over by FBCCI Administrator Mr. Md. Hafizur Rahman.

A delegation from UKBCCI visited Bangladesh to explore potential sectors and to enhance trade and investment in Bangladesh. The delegation was led by UKBCCI Chairman Iqbal Ahmed. This is the first

visit of a UK business delegation to Bangladesh since the interim government assumed office.

During the meeting, the FBCCI Administrator said that Bangladesh has continued to provide necessary assistance to create a conducive environment for trade and investment in the country.

The FBCCI Administrator also called upon all entrepreneurs in the UK, including British-Bangladeshi businessmen, to invest in Bangladesh's potential sectors and utilize the market opportunities.

He suggested that the two countries should move forward quickly on issues such as Free Trade Agreement (FTA) and Preferential Trade Agreement (PTA) to harness the benefits of regional and global supply chains. UK Parliament Member Rupa Haque expressed her interest in working closely with businessmen from both the countries to promote bilateral trade.

UKBCCI Chairman Iqbal Ahmed said that expatriate businessmen are interested to invest in Bangladesh. He emphasized on restoring discipline in the country's financial sector to attract desired investment.

Inaugural Ceremony of DITF 2025




FBCCI Administrator Md. Hafizur Rahman attended the inauguration ceremony of the Dhaka International Trade


ABBF President paying courtesy visit to FBCCI Administrator
